Parent & Tot Classes

The total fee for the 12-week session is \$95.00. A non-refundable registration fee of \$40.00 is due at the time of registration and a post-dated cheque for the remaining \$55.00 (dated Sept. 1/08 for the Fall Session and Jan. 1/09 for the Winter Session) should be included with the registration form. A \$15.00 fee will be levied for any NSF cheques. **NO REFUNDS WILL BE ISSUED AFTER THE FIRST CLASS.**

Step 1, 2, 3, Ensemble and Recorder 2 Classes

The total annual fee is \$340.00. A non-refundable registration fee of **\$40.00 per family** is due with the registration form. **There are two options for paying the remaining tuition of \$300.00.** Please note that a \$15.00 fee will be levied for any NSF cheques.

Option 1

A non-refundable registration fee of \$40.00 per family dated for the day of registration plus eight post-dated cheques in the amount of \$37.50 each, dated for the first of each month beginning Sept. 1, 2008 and ending April 1, 2009. **All cheques are to be submitted at the time of registration.**

Option 2

A non-refundable registration fee of \$40.00 per family dated for the day of registration plus two post-dated cheques in the amount of \$150.00 each, dated the September 1, 2008 and January 1, 2009. **All cheques are to be submitted at the time of registration.**

CANCELLATION POLICY

All classes are subject to cancellation pending adequate registration. In this case, full refunds will be issued.

A written request to withdraw from a class must be submitted **one full month** prior to the requested withdrawal date. Following receipt of this request, a pro-rated refund will be issued. **No withdrawals will be accepted after February 28, 2009.**
